**MOTION OF THE TRUSTEE FOR THE ENTRY OF AN ORDER
UNDER BANKRUPTCY CODE SECTION 105(A) AND
BANKRUPTCY RULE 9006 FURTHER EXTENDING TIME TO OBJECT TO CLAIMS**

FTI Consulting, Inc., as the Trustee for the trusts established under the confirmed Plan of Reorganization of Advanta Corp., et al. (the “Trustee”), by and through its co-attorneys, Latham & Watkins LLP and Drinker Biddle & Reath LLP, hereby moves (the “Motion”) for the entry of an order pursuant to section 105(a) of chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”), Rule 9006 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and the *Debtors’ Joint Plan Under Chapter 11 of the Bankruptcy Code*, further extending the Claims Objection Deadline (defined below) to December 29, 2017. In support of this Motion, the Trustee respectfully represents as follows:

JURISDICTION AND VENUE

1. This Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334 and Article 7.2 of the Plan. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

2. The statutory predicate for the relief requested herein is section 105(a) of the Bankruptcy Code. Such relief is also warranted under Bankruptcy Rule 9006.

BACKGROUND

3. On November 8, 2009 (the "Petition Date"), Advanta Corp. and certain other debtors each commenced a chapter 11 case in this Court by filing a voluntary petition for relief under the Bankruptcy Code, and on November 20, 2009, the remaining debtors filed chapter 11 petitions.

4. On November 2, 2010, Advanta Corp. and its affiliated debtors (the "Debtors") filed with the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") the Disclosure Statement for Debtors' Joint Plan Under Chapter 11 of the Bankruptcy Code (as modified, the "Disclosure Statement"), and the Debtors' Joint Plan Under Chapter 11 of the Bankruptcy Code (as modified, the "Plan"). On December 17, 2010, the Bankruptcy Court entered an order approving the Disclosure Statement, as modified (the "Disclosure Statement Order"). On February 11, 2011, the Order confirming the Plan was entered by the Bankruptcy Court. The Effective Date occurred on February 28, 2011 (the "Effective Date"), and the Plan (as modified February 28, 2011) was substantially consummated.

5. Pursuant to, among other sections, section 7.2 of the Plan, the Trustee was granted authority to evaluate and prosecute, among other things, objections to claims (the "Claims"), and actions to recover alleged transfers that are subject to avoidance under applicable

provisions of the Bankruptcy Code. Further, pursuant to section 7.2 of the Plan, objections to the Claims must be served and filed:

(i) on or before the one-hundred-and-eightieth (180th) day following the later of (x) the Effective Date, and (y) the date that a proof of Claim is filed or amended or a Claim is otherwise asserted or amended in writing by or on behalf of a holder of such Claim, or (ii) on such later date as may be fixed by the Bankruptcy Court, whether fixed before or after the date specified in clauses (x) or (y) above (the "Claims Objection Deadline").

6. On July 13, 2011, the Trustee filed its first Motion to Extend Time to Object to Claims (Docket No. 1301). On August 9, 2011, the Bankruptcy Court entered an Order Granting the Motion to Extend Time to Object to Claims (Docket No. 1306), extending the Claims Objection Deadline through November 8, 2011. Additional orders have been entered extending the Claims Objection Deadline through the current Claims Objection Deadline of April 26, 2016. See Docket Nos. 1326, 1494, 1511, 1538, 1579, 1593, 1609, 1616, 1626 & 1643.

7. For the reasons set forth below, the Trustee seeks the entry of an order of the Bankruptcy Court pursuant to Article 7.2 of the Plan further extending the Claims Objection Deadline through and including December 29, 2017.

RELIEF REQUESTED

8. By way of this Motion, the Trustee seeks the entry of an order, substantially in the form attached hereto as **Exhibit A**, extending the Claims Objection Deadline through and including December 29, 2017. The Trustee further requests that the extension herein be granted without prejudice to its right to seek further extensions of the Claims Objection Deadline.

BASIS FOR RELIEF

9. As demonstrated above, the Claims Objection Deadline may be extended by order of the Court pursuant to the Section 7.2 of the Plan.

10. Bankruptcy Code section 105(a) provides that “[t]he court may issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of this title,” 11 U.S.C. § 105(a), and it is generally recognized that “[s]ection 105(a) authorizes the bankruptcy court . . . to fashion such orders as are required to further the substantive provisions of the [Bankruptcy] Code.” See In re Morristown & E.R. Co., 885 F.2d 98, 100 (3d Cir. 1989).

11. Federal Rule of Bankruptcy Procedure 9006(b)(1) permits the Court, in its discretion, to extend the Claims Objection Deadline for cause, with or without motion or notice. Bankruptcy Rule 9006(b)(1) provides in pertinent part:

[W]hen an act is required or allowed to be done at or within a specified period . . . by order of court, the court for cause shown may at any time in its discretion (1) with or without motion or notice order the period enlarged if the request therefore is made before expiration of the period prescribed or as extended by a previous order . . .

FED. R. BANKR. P. 9006(b)(1).

12. The Trustee is making the request in this Motion before the expiration of the current Claims Objection Deadline, and, accordingly, this request complies with Bankruptcy Rule 9006(b)(1).

13. Although Bankruptcy Rule 9006 does not define “cause,” it has been noted that “courts should be liberal in granting extensions of time sought before the period to act has elapsed, as long as the moving party has not been guilty of negligence or bad faith and the privilege of extensions has not been abused” 10 Collier on Bankruptcy (15th ed. rev. 2008 at 9006-14).

14. In the context of determining whether “cause” exists regarding extensions of time, courts have considered such factors as the size and complexity of the issues involved, the good faith progress being made towards resolving those issues, and the amount of time elapsed

in the case. See, e.g., In re Cent. Jersey Airport Servs., 282 B.R. 176, 184 (Bankr. D.N.J. 2002); In re Adelpia Communs. Corp., 336 B.R. 610, 674 (Bankr. S.D.N.Y. 2006); In re Express One Int'l, 194 B.R. 98, 100 (Bankr. E.D. Tex. 1996).

15. It is respectfully submitted that cause exists to extend the Claims Objection Deadline through, and including, December 29, 2017. Together, the Trustee and the Debtors have filed numerous claims objections. In addition, the Trustee has successfully negotiated consensual resolutions with respect to certain significant Claims that were filed against the Debtors' estates and has made four interim distributions to creditors. The four interim distributions represent the following cumulative recoveries: Retail Note Claims against the AC Liquidating Trust recovered 100 cents on the dollar; and General Unsecured Claims against the AC Liquidating Trust recovered 59.3 cents on the dollar. The Trustee intends to make an additional distribution in the near future and is continuing the process of winding down certain of the remaining entities and trusts, which process may continue throughout calendar years 2016 and 2017 due to the requirement that the Trustee obtain final tax clearance from the relevant taxing authorities. Although the Trustee does not anticipate filing any further claims objections in these cases, out of an abundance of caution, the Trustee requests that the Court extend the Claims Objection Deadline during the wind down process such that the Trustee can be certain that all claims have been reconciled.

16. This is the Trustee's twelfth requested extension of the Claims Objection Deadline. Accordingly, the Trustee respectfully submits that an extension of the Claims Objection Deadline to December 29, 2017 is warranted and is in the best interest of creditors, parties-in-interest, and judicial economy.

NOTICE

17. A copy of this Motion is being served by CM/ECF upon the Office of the United States Trustee and all parties who have formally requested notices in this case pursuant to Federal Rule of Bankruptcy Procedure Rule 2002. In light of the nature of the relief requested herein, the Trustee submits that no other or further notice of hearing is required and such additional notice be excused under the circumstances.

WHEREFORE the Trustee respectfully requests entry of the Order granting the relief requested herein and such other and further relief as the Court may deem just and appropriate.
