**CERTIFICATION OF COUNSEL REGARDING OMNIBUS ORDER

1. The professionals (the “**Professionals**”) identified on the form of order attached hereto as **Exhibit 1** (the “**Omnibus Order**”) and Warren H. Smith & Associates, P.C., the fee auditor appointed in these chapter 11 cases (the “**Fee Auditor**”), have filed and served interim fee applications (collectively, the “**Interim Applications**”) pursuant to the *Order Pursuant to Sections 330 and 331 of the Bankruptcy Code and Bankruptcy Rule 2016 Implementing Certain Procedures for the Interim Compensation and Reimbursement of Professionals* [Docket No. 102] and the *Order Appointing Fee Auditor and Establishing Related Procedures Concerning the Payment of Compensation and Reimbursement of Expenses of Professionals and Members of Official Committees and Consideration of Fee Applications* [Docket No. 249]. **OMNIBUS ORDER APPROVING

Official Committees and Consideration of Fee Applications [Docket No. 249] (the “**Fee Auditor Order**”); the Court having reviewed the Applications and the Court-appointed fee auditor’s (the “**Fee Auditor**”) final reports with respect to each Application; and the Court finding that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) notice of the Applications was adequate under the circumstances; and (c) all parties with notice of the Applications have been afforded the opportunity to be heard on the Applications; now therefor

IT IS HEREBY ORDERED THAT:

1. The Applications are GRANTED to the extent set forth on the attached Exhibit A.
2. Each of the Applicants is allowed (a) compensation for services rendered during the Compensation Period and (b) reimbursement for actual and necessary expenses incurred during the Compensation Period, in the respective amounts set forth as approved on the attached Exhibit A, including any and all amounts heldback.
3. To the extent not already paid pursuant to the Administrative Order, the above-captioned debtors and debtors in possession are authorized and directed to pay each of the Applicants 100% of the fees and 100% of the expenses listed on Exhibit A hereto under “Interim Fees Approved” and “Interim Expenses Approved”, respectively, for services rendered and expenses incurred during the Compensation Period; provided, however, that all fees and expenses paid as authorized herein remain subject to final allowance by the Court.
